

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.bradiantphotography.com and B Radiant LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to B Radiant LLC include www.candacebrown.biz and BRP LLC. The BRP LLC website is an ecommerce site. By using the BRP LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, B Radiant LLC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase B Radiant LLC 's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

B Radiant LLC may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Race

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

BRP LLC collects and uses your personal information to operate its website(s) and deliver the services you have requested.

B Radiant LLC may also use your personally identifiable information to inform you of other products or services available from B Radiant LLC and its affiliates.

Sharing Information with Third Parties

B Radiant LLC does not sell, rent or lease its customer lists to third parties.

B Radiant LLC may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. B Radiant LLC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. Tracking User Behavior

B Radiant LLC may keep track of the websites and pages our users visit within B Radiant LLC, in order to determine what B Radiant LLC services are the most popular. This data is used to deliver customized content and advertising within B Radiant LLC to customers whose behavior indicates that they are interested in a particular subject area.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by B Radiant LLC. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the B Radiant LLC website.

Use of Cookies

The B Radiant LLC website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Right to Deletion

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen

B Radiant LLC does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
